#### **Mission Statement**

#### **SECTION 1:**

#### Introduction

St Saviour's Catholic Primary and Nursery School aims to treat all its pupils fairly and with respect. This involves providing access and opportunities for all pupils without discrimination of any kind. The plan will be made available on the school website, and paper copies are available upon request.

Our school is also committed to ensuring staff are trained in equality issues with reference to the Equality Act 2010, including understanding disability issues.

The school supports any available partnerships to develop and implement the plan. Our school's complaints procedure covers the accessibility plan. If you have any concerns relating to accessibility in school, this procedure sets out the process for raising these concerns.

We have included a range of stakeholders in the development of this accessibility plan, including pupils, parents, staff and governors of the school.

#### **Definition of Disability**

Disability is defined by the Disability Discrimination Act 1995 (DDA).

"A person has a disability if he or she has physical or mental impairment that has a substantial and long term adverse effect on his or her ability to carry out normal day to day activities".

#### **Legislation and guidance**

This document meets the requirements of <u>schedule 10 of the Equality Act 2010</u> and the Department for Education (DfE) <u>guidance for schools on the Equality Act 2010</u>. The Equality Act 2010 defines an individual as disabled if he or she has a physical or mental impairment that has a 'substantial' and 'long-term' adverse effect on his or her ability to undertake normal day to day activities.

Under the <u>Special Educational Needs and Disability (SEND) Code of Practice</u>, 'longterm' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial'. The definition includes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make 'reasonable adjustments' for pupils with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a disabled pupil faces in comparison with non-disabled pupils. This can include, for example, the provision of an auxiliary aid or adjustments to premises.

#### **Key Objectives**

To reduce and, where possible, eliminate barriers to accessing the curriculum and for pupils to have full participation within the school community.

#### **Principles**

Compliance with the DDA and the Equalities Act 2010 is consistent with St Saviour's aims and commitment to equalities and the operation of our SEND policy. St Saviour's Catholic Primary and Nursery School recognises its duty under the DDA (as amended by the SENDA)

- Not to discriminate against disabled pupils in their admissions and provision of education and associated services
- Not to treat disabled people less favourably
- To take reasonable steps to avoid putting disabled pupils at a substantial disadvantage
- To publish an Accessibility Plan

St Saviour's recognises and values parents' knowledge of their child's disability and the effect on his/her ability to carry out routine activities, and respects the parents and child's right to confidentiality.

St Saviour's Catholic Primary and Nursery School provides all pupils with a broad and balanced curriculum, differentiated and adjusted to meet the needs of individual pupils and their preferred learning styles; and endorses the key principles in the National Curriculum 2000 framework, which underpins the development of a more inclusive curriculum.

- Setting suitable learning challenges
- Responding to pupil's diverse learning needs
- Overcoming potential barriers to learning and assessment for individual groups of pupils

#### **Activity**

- a) Education and related activities St Saviour's will continue to seek and follow the advice of the LA services, such as specialist teacher advisors and SEN advisors/keyworkers and of appropriate health professionals from local NHS Trusts.
- b) Physical environment
  At St Saviour's, we will take account of the needs of pupils and visitors with
  physical difficulties and sensory impairments when planning and undertaking
  future improvements and refurbishments of the site and premises.
- c) Provision of information St Saviour's Catholic Primary and Nursery School will make itself aware of local services, including those provided through the LA, for providing information in alternative formats when required or requested.

St Saviour's will continue to work in partnership with outside agencies in order to ensure the best outcomes for all pupils e.g. CAMHS, I-Art, Family Support and Outreach services
